

X -Zone LIABILITY WAIVER AND HOLD HARMLESS AGREEMENT

As parent or legal guardian of the child whose name is set forth (who is referred to herein as the “participant”) and in consideration of the Participant being permitted to participate in the activities (as define below) conducted by X Zone Indoor Playground, the Participant and I agree as follows:

1. **Assumption of Risk**, -I understand that the X Zone playground facility entail the risk of severe bodily to the Participant. Injuries that could result will vary but may include (a) minor injuries such as scratches, bruises, and sprains; (b) major injuries such as wye injury or loss of sight, joint or back injuries and concussions; and (c) catastrophic injuries, including paralysis and even death. **Notwithstanding these risk and other hazards that may be foreseeable but not specifically identified herein, I, for myself and the Participant and our respective heirs, personal representatives and assigns, understand, acknowledge, and expressly and voluntary assume all risk and fully responsibility for any injury arising out of or related to the activities conducting in X Zone playground and party hall facility**
2. **Release, Discharge and Agreement not to Sue**, -I, for myself and the Participant and our respective heirs, personal representatives and assigns, do hereby release, discharge and agree not sue X-zone, and it’s managers, members, employees and other agents for any injury, to or death of the Participant arising , directly or indirectly, from the participation of the activities, this release, discharge and covenant not to sue shall relate to any and all claims of legal rights now existent or arising in the future, including claims and legal rights arising out of any negligence of X-zone and/or its managers, members, employees, and/ or the agents of any breach of a legal duty arising out from common law, statute, contract or otherwise.
3. **Indemnification and Hold Harmless** - I agree to indemnify X-zone and hold X-zone harmless from, without limitations, any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney’s fee and costs, incurred due to claims brought by any third party as a result of or arising out of the Participant’s involvement in the actives and to reimburse X-zone for any such cost, expenses and fees as they are incurred. I will ensure, for myself, my child, and anyone under my supervision, that all the rules and regulations of X-zone playground, expressly including proper use of the facilities, are strictly followed. I shall not permit anyone in my party to engage any activities or use the facilities for which I do not understand proper use.
4. **Parent or Legal Guardian Certification and Consent**-I hereby certify that I am the parent or Legal guardian of the Participant whose name appears below. And I have authority to waive rights on behalf of the minor participant. I have read and understand all of the provisions of this document and the risks of the activities. I understand that the Activities. I understand that the activities could cause injury and even death. I acknowledge, and I have read and understand the terms of this document and I am freely and voluntary signing this document.
